

ACKNOWLEDGEMENT AND WAIVER OF LIABILITY

A separate waiver is required for each adult attendee for each booking.

The Tate Ski Club Co-operative Limited (**Club**) has put in place a number of preventative measures to reduce the spread of COVID-19. However, the Club cannot guarantee that you, your guests or anyone else will not become infected with COVID-19. Further, attending the Club could increase your risk of contracting COVID-19 particularly considering the use of shared spaces including bathrooms.

I acknowledge and agree:

1. The Club has adopted a COVID-19 Management Plan. I have familiarised myself with it and will comply with the plan and ensure my guests do the same.
2. I will comply with any direction from the Lodge Captain.
3. I will abide by all Australian Federal and State Health legislation, guidelines, orders and directives regarding movement, testing, isolation and quarantine; in particular those relating to the Snowy-Monaro LGA and my own LGA; and will ensure I keep up to date on any changes to these on a daily basis during my stay.
4. I will not attend the Club premises if I or a household contact of mine has visited an identified location where those who have attended that location have been directed or advised to self-isolate and that direction or advice remains applicable.
5. I will comply with all Federal and State Government legislation, social distancing requirements and guidelines including the requirement to remain at a distance of 1.5 metres from any other individual and mask-wearing when health orders or the club require it at the time of your stay at the Lodge.
6. I and my guests will not attend the Lodge whilst displaying any flu like, cold or sore throat symptoms, even if a negative COVID-19 test has been obtained, and will advise the booking officer of the need to cancel/amend the booking. If I or any of my guests display any such symptoms whilst staying at the Lodge then I must immediately notify the Lodge Captain and vacate the Lodge as soon as possible.
7. I am responsible for ensuring that all my guests comply with all COVID-19 requirements.
8. I acknowledge that any breach or non-compliance with any COVID-19 requirements whether imposed by the NSW Government or the Club may lead to a direction being issued to me and/or my guests by the Board, Bookings Officer or Lodge Captain to immediately leave the premises. If such a direction is issued I will comply with it.
9. By signing this form I agree to the above conditions and acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that me or my guests may be exposed to or affected by COVID-19 by attending the Club and that such exposure or infection may result in personal injury, illness, permanent disability or death. I further understand that the risk of becoming exposed or infected by COVID-19 at the Club may result from the actions, omissions or negligence of myself or others including but not limited to Club employees and volunteers.
10. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to me or my guests that occur in connection with attendance at the Club's premises.
11. I hereby release, discharge and hold harmless the Club, its employees, agents and representatives of and from any claims including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on acts or omissions of the Club, its employees, agents and representatives whether the COVID-19 infection occurs before, during or after my attendance at any Club premises.
